FAILURE TO CHECK IN BY 8:30 AM WILL RESULT IN REMOVAL FROM THE TOURNAMENT.

WEIGH-IN: *Honor System - no weigh- ins.* Please submit weight to tenth of a pound.
Must be within 2 pounds in singlet and wrestling shoes. Scale will be available for challenges.

FORMAT: 5 Man Round Robin - whenever possible. Madison system will be used.
Three mats will be used - stay on the same mat all day!

RULES: * Age as of 12/17/11 - Must have proof of age (from both parties) if challenged!
* PIAA modified rules * All bouts 1-1-1(OT-Sudden victory) * Headgear/Singlet Optional
* No weight class changes after registration.
